I understand that any artist found to misrepresent his / her art will be asked to leave the Festival. Application and booth is for an individual Artist only. No guild or group booths will be accepted.

All completed applications, California resale cards with valid number, photos and booth fees must be received 1 month prior to above Festival date, to allow for judging of submitted materials, pre-show resale license verification by the California State Board of Equalization, and return of materials.

The number of booth spaces available is limited. All applications will be judged for acceptance on a first come, first serve basis. Booth spaces will be allotted by category. Once a category is full no more applications for that category will be accepted.

This is an Art Festival and we will not accept applications from clothing vendors. All artists must be present. Food vendors have a separate application process.

**Some Rotarians are willing to open their homes to artists to stay at during the weekend. If you would like to take advantage of this complimentary invitation, please let us know. There will also be a complimentary breakfast served at the festival for artists Sunday morning from 8-9:30.**

ARTIST APPLICATION

LAKE ARROWHEAD ROTARY CLUB hereinafter referred to as ROTARY, and \_\_\_\_\_ hereinafter referred to as ARTIST, agree as follows;

ARTIST has requested from ROTARY the opportunity of exhibiting his / her artwork in the annual Lake Arrowhead Rotary Art & Wine Festival, **Saturday from 10:00 a.m. to 7:00 p.m. and Sunday from 11:00 a. to 4:00 p.m.**, on dates given on the front side of this application.

ARROWHEAD LAKE ASSOCIATION and / or LAKE ARROWHEAD VILLAGE, hereinafter referred to as LESSOR, is agreeable to granting ROTARY and ARTIST a revocable license for said purpose of displaying artwork at the LESSOR'S facilities at either Tavern Bay Beach Club and/or Lake Arrowhead Village. Lake Arrowhead, providing such displaying and conjunction of festival does not in any way interfere with, destroy, or damage the property of LESSOR.

Said license may be revoked at any time by LESSOR acting through any office or authorized agent. Said license is personal to ROTARY and ARTIST and is not assignable in whole or in part in any way.

Said license does not convey, grant or otherwise transfer to ROTARY and / or ARTIST any rights, title or interest in LESSOR'S REAL PROPERTY, including but not limited to a license coupled with any interest.

ARTIST agrees to indemnify and hold ROTARY and LESSOR harmless from any loss, liability or claim in connection with damage or injury to his artwork, to LESSOR'S said facilities or customers, to passers-by, and to any other person or persons, or their property with respect to or in any way connected with said display of said artwork, or any other activity of ARTIST.

ARTIST agrees to allow the use of their name, contact and website information to help promote the festival and artist.

ARTIST agrees to provide, at his own expense, a full and adequate defense for ROTARY and LESSOR of any lawsuit or action relating in any way to his display of artwork and to promptly pay any judgment rendered against ROTARY and / or LESSOR in any such suit or action, including attorney fees incurred by either.

ARTIST and ROTARY agree that they will maintain the licensed facilities in a clean, tidy and safe condition during their use of said facilities, and they shall leave said facilities in a clean, tidy and safe condition at and after each use of said facilities, and at the end after the termination or revocation of said license.

LESSOR and ROTARY, in granting said license to ARTIST, undertake no liabilities, obligation or responsibilities to any person or group of persons for any artwork including, but not limited to, ARTIST, viewers, agent employees, servants, licensees or invitees.

Nothing contained in this agreement shall be construed or deemed by the parties hereto, or by any other person to create the relationship of principal and agent, or of a partnership of joint venture, or of any association between the parties hereto, other than set forth herein.

The purpose of the Festival is to raise funds to be used for the many charitable programs engaged in by the LAKE ARROWHEAD ROTARY FOUNDATION. Therefore, there is an exhibition site fee of \$250.00. **NO COMMISSION PAID**, only the exhibition site fee.

**GENERAL POLICY:**

Only one exhibitor is allowed per space. Exhibitors are to bring their own booth materials.

The artist's work will be juried by category and selected for quality and originality. Jurors consist of Rotary members.

**HOURS:**

Festival hours are 10:00-7:00 Saturday, and 11:00-4:00 Sunday. **Exhibitors are not permitted to tear down before 7:00 p.m.** Setup time is 7:00 a.m. to 9:30 a.m. Must be ready for business by 10:00 a.m. Space will be forfeited if not occupied by 9:00 a.m. the first day of the Festival.

**SPACE ASSIGNMENT:**

Space will be assigned on a first come first served basis. Space sizes vary (approximately 10' X 12').

**DEADLINE:**

Deadline to enter is May 31, 2010

**REFUNDS:**

No space reservations refunds can be made after 30 days prior to the festival. If the entire event is cancelled as a result of either inclement weather, acts of nature, or restrictions by government agencies, there will be a 50% refund of registration fee.

**TAXES:**

**All vendors are responsible for their own sales tax and must provide a valid California sales tax I.D. number on front side of this application.**

**EXHIBITOR PARKING:**

**All vehicles must be removed from the festival area by 9:30 a.m.. Parking only in designated exhibitor parking area.**

**OTHER:**

**ANIMALS ARE NOT ALLOWED IN THE FESTIVAL AREA.**

The committee of the Lake Arrowhead Rotary Art and Wine Festival reserves the right to change or substitute vendor spaces for the good of the Festival and its participants.

The Committee reserves the right to limit the number of participants for any one particular art medium, thereby protecting all vendors and maintaining diversity for the Art & Wine Festival.

The Committee reserves the right to alter the format or character of the Festival at its discretion, in order to enhance and improve the future of the Lake Arrowhead Rotary Art & Wine Festival.
